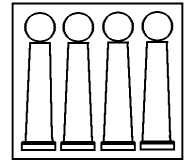

Dismissal Docket Rule 37.1 Modified

On May 7, 2001, the Court en banc approved the following modification of Local Court Rule 37.1, pending review by the BCBA and the Callaway Bar:

Rule 37.1—Dismissal Docket

A. Circuit Civil

All cases remaining inactive and on file for a period of six (6) months shall, upon 30 days written notice to the parties or their attorney, be dismissed without prejudice for failure to prosecute, except for good cause shown. Further, a request for a case on the dismissal docket to be placed on the trial request docket shall not be made except for good cause shown and upon written motion submitted with notice to all parties. Adverse parties shall have at least ten (10) days notice within which to file written memorandum in opposition to said motion.
