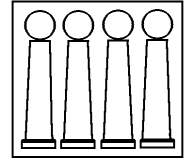

Conley delivers report on judiciary

Judge Frank Conley delivered his annual State of the Judiciary address to the BCBA on September 19, 2001.

Speaking to a crowd of 75 lawyers, Judge Conley discussed the circuit's various diversionary programs that help reduce the number of incarcerated criminals. Judge Conley said it was important that the local Bar be made aware of the effort made by the criminal justice system to reduce inmate populations as some in the community were under the impression that little attention was being given the problem.

Judge Conley expressed satisfaction with the criminal caseload's compliance with the Missouri Supreme Court's time standards but suggested that changes were on the horizon for the civil caseload.
