#### Law School enrolls 154

The MU Law School has started the Fall Semester with an incoming class of 154 first-year students, according to Dean **R. Lawrence Dessem**. The average age of the new students is 24. Sixty-one percent are male, 39% are female, and 86% are from Missouri.

The new class brings the highest median grade point average (3.36) and Law School Admissions Test score (top 26%) ever recorded at the school.

The largest number of new students came from MU (58), Truman State (12) and Southwest Missouri State (8).

One of the new students is a physician, while others hold advanced degrees in business, accounting, journalism and theology. Also in the class are several police officers, some reporters and an editor, a college professor, some clergymen, and many students who have just completed an undergraduate degree.

#### Oxenhandler to be sworn in Oct. 11

**Gary Oxenhandler** will be sworn in as Division II Circuit Judge of the 13<sup>th</sup> Judicial Circuit at a public ceremony at 3:30 p.m. Friday, Oct. 11, in the Ceremonial Courtroom at the Boone County Courthouse. He will begin his judicial duties the following week.

Gov. Bob Holden appointed Judge Oxenhandler to succeed Frank Conley on Sept. 26. Other candidates considered, upon the recommendation of the Boone County Democratic Central Committee, were **Skip Walther** and **Debbie Daniels**.

A Columbia lawyer since his graduation from the MU Law School in 1973, Judge Oxenhandler practiced mainly in the areas of business and real estate, family law and estate planning.

Judge Oxenhandler has been an active participant on civic boards, including the Mayor's Race Relations Task Force in 1996, the Boone County Jail Task Force in 1997 and the Judicial and Law Enforcement Task Force in 2000.

In a prepared statement, Gov. Holden said, "Gary Oxenhandler brings to the bench an understanding of the judicial system from long experience as a practicing attorney. He is a respected civic leader who will continue the tradition of judicial excellence exemplified by Judge Conley."

### Conley, Hamilton speak on 'State of the Court' at Sept. 18 meeting

A near-capacity crowd of 85 turned out to hear outgoing Presiding Judge Frank Conley and incoming President Judge Gene Hamilton speak at the Sept. 18 luncheon meeting of the Boone County Bar Association at Boone Tavern.

Judge Conley, whose retirement was effective on his 70<sup>th</sup> birthday on Sept. 30, noted that the judiciary has changed appreciably since he became a judge in 1970. When he started, most judges were older, and all were male. Now many judges are younger and female.

Judge Conley praised the quality of our local bar and thanked bar members for their help in doing the court's work. He said one of the most important things for bar members to do is continue practicing civility.

Judge Hamilton noted that when Judge Conley took the bench, there were few dissolution actions, no paternity cases, orders of protection were unheard of, and there were only two circuit judges and two magistrates.

Now, Judge Hamilton noted, such cases are commonplace, and there are three circuit judges, six associate circuit judges, and one commissioner hearing cases in Boone County.

Judge Hamilton praised Judge Conley's abilities as a court administrator and said he starts with many advantages—an effective and efficient local court system, a good group of judges, a good court administrator (Bob Perry), and one of the best local bars in the state.

Judge Hamilton said he will have an "open door policy" and invited bar members to visit, call or write to him with ideas for improvement of the court.

Initiatives in the near future are expected to be implementation of a Mental Health Court presided over by Judge **Christine Carpenter** and continued exploration of alternatives to incarceration, an area in which Boone County has been a leader.

Judge Hamilton made this pledge to BCBA members: "I

will always try to remember from whence I came. I will always try to dispense justice fairly."

In closing, Judge Hamilton read a quotation from an unknown source that he said he tries to keep in mind at all times: "Courts exist to promote justice and thus to serve the public interest. Their administration should be speedy and careful. Every judge should at all times be alert in rulings in the conduct of the business of the court to make it useful to litigants and the community. The judge should avoid unconsciously falling into the attitude of mind that the litigants are made for the courts instead of the courts for the litigants."

### Court announces docket changes, rule change and new filing fee list

The 13<sup>th</sup> Circuit Judicial Court has announced several recent changes.

With the retirement of Judge Frank Conley and the appointment of Gary Oxenhandler to succeed him as Division II judge, the Law Day schedules for Divisions I and II will be changed.

The main change is that effective Oct. 1, new Presiding Judge **Gene Hamilton**, Division I, will have the Law Day schedule that Division II formerly had, and Judge Oxenhan-

dler will have the Law Day schedule that Judge Hamilton formerly had.

Other minor changes are that the Division I criminal docket in Boone County on the third Monday will start at 2 p.m. instead of 1:30, and the Division II criminal docket on the first Monday in Boone County will start at 1:30 p.m. instead of 2.

Also effective Oct 1, Judge **Joe Holt**, Division VI, will be in Boone County on the second Thursday for contested dissolutions instead of being in Calla-

way County.

Updated docket schedules are available on the BCBA's web site in browser-viewable format at www.bocomobar.org/schedule.htm On the same page the court's official docket schedule can be downloaded in Microsoft Word format.

The court also has revised Local Rule 6.7 to include the following additional sentence: "In the absence of both the presiding judge and the acting presiding judge, the judge of the division with the lowest division

number shall have the authority to perform the duties of the presiding judge." The revised rule appears on the web site at www. bocomobar.org/administration. htm.

Finally, the court has promulgated a new schedule of filing fees and cost deposits which can be downloaded in Microsoft Word format at www. bocomobar.org/filing\_fees.htm. A summary of fees and cost deposits also appears on that page in browser-viewable format

# More than 550 attend Judge Conley's Retirement Dinner

On the evening of Sept. 27, a near-capacity crowd of between 550 and 600 people filled all three bays of the ballroom area at the Holiday Inn Select Executive Center for Judge **Frank Conley**'s Retirement Dinner.

After a reception beginning at 6 p.m., Judge **Gene Hamilton** welcomed the guests at 7, and the Rev. Richard Ramsey, First Presbyterian Church, where Judge Conley has been a long-time member, gave the invocation before dinner was served.

The after-dinner program was kicked off by Bob Pugh and **Doug Pugh** narrating a light-hearted digital slide show recounting Judge Conley's life. The slide show was put together by **Dan Atwill**, immediate past BCBA president, who also cochaired the Conley Retirement Dinner Committee.

Remarks were then made by Missouri Supreme Court Chief Justice Stephen Limbaugh Jr., Tom Dunlap representing the Callaway County Bar Association, **Kevin Crane** and **Dan Atwill** representing the BCBA, and Eric Engberg, who recently retired from CBS News and who became a friend of Judge Conley's while working as KFRU news director in the 1960s.

Judge Conley made some brief remarks expressing appreciation for the opportunity to serve so many years as a trial judge and thanking the guests for their attendance.

The evening closed with the recitation of a special poem by Judge Hamilton, the "poet laureate" of the Boone County Courthouse (see the adjacent box).

#### Brief biography of Judge Conley

Here is a brief biography of Judge **Frank Conley**, whose mandatory retirement at age 70 took effect on Sept. 30:

Judge Conley was the eldest of four sons of Sanford Conley Jr. and Eleanor Conley. His father died in 1947. He attended University High School where he played basketball. He then finished undergraduate and law degrees at MU in five years, graduating in 1956.

After a brief stint in an Army artillery unit as a second lieutenant, he returned to Columbia and entered private practice with Howard Major. He married Carla Hayzlett in 1957, and

they have three adult children.

He won election as Boone County Prosecuting Attorney in 1962 and served in that position until his election as Circuit Judge in 1970.

He is a long-time member and elder of First Presbyterian Church. Other memberships include the Rotary Club of Columbia, Pi Delta Theta and Phi Delta Phi.

He served on numerous committees appointed by the Missouri Supreme Court, including the Supreme Court Budget committee, the Committee on Judge Transfers, and the Committee on Critical Issues.

#### Conley, Whitmarsh receive awards

Boone County Circuit Judge Frank Conley and Circuit Clerk Cheryl Whitmarsh received awards from Missouri Supreme Court Chief Justice Stephen Limbaugh Jr. at the Judicial Conference on Sept. 13 in Kansas City.

Judge Conley was honored by

a Chief Justice's Award for "exemplary service to the judiciary and outstanding contributions to the administration of justice" during his 30 years as a 13<sup>th</sup> Circuit Judge.

Whitmarsh's award cited her leadership in implementation of court automation.

The public wants a judge who's fair, but with a firm approach, A judge whose reputation is far above reproach, Who's honest and courageous, and fiercely independent, Dispensing justice fairly to both plaintiff and defendant.
