Picnic, other events planned

Also, don't forget that the Missouri Bar's Annual Meeting will be held in Columbia for the first time **Oct. 1-3**. The Missouri Bar recently mailed registration materials to lawyers, and the BCBA encourages full participation by local lawyers.

It is anticipated that the "State of the Court" program traditionally presented in September will be the program at a regular meeting in **Oct. 8**.

Nominating Committee appointed

Lorri Shurtleff has been appointed chair of the BCBA Nominating Committee, which will present a slate of proposed 2003-2004 officers at the annual picnic and election on Sept. 12. President Betty Wilson also announced that the other members of the Nominating Committee are Ron Smull, Marsha Fischer and C. J. Dykhouse.

Officers to be nominated are president, vice president, secretary, treasurer, and two at-large Executive Committee members. The immediate past president automatically becomes an Executive Committee member. The proposed slate of officers will be published in early September.

Bar members may make suggestions for officer candidates to the Nominating Committee members. Under BCBA bylaws, nominations also may be made from the floor at the picnic with the consent of the nominees.

CLE credit given for July 9 'Ethics Counsel' program

The topic will be Missouri's new Legal Ethics Counsel. The speaker will be Sara Rittman, who has been the Legal Ethics Counsel since Jan. 1 this year.

As usual when a CLE-credit program is presented, lunch service will begin at 11:30 a.m. The program will begin at 12:10 p.m. after a brief business meeting. The lunch price will be \$9, payable to Boone Tavern.

The office of the Legal Ethics Counsel issues informal advisory opinions on ethical issues submitted by lawyers, a function formerly performed by the Office of the Chief Disciplinary Counsel.

The program will cover the changes to Rule 5 that led to the creation of the Legal Ethics Counsel, including some of the history of the change; how to request an informal advisory opinion; the status of informal and formal advisory opinions and how to find them; and common issues submitted by lawyers.

As Legal Ethics Counsel, Sara Rittman provides oral and written informal advisory opinions to lawyers and serves as counsel to the Supreme Court Advisory Committee.

She received her B.S.Ed. from MU in 1978 and a J.D. from UMKC in 1981. In 1981 she began work as an assistant atomey general, and in 1985 she became unit chief of the AG's Professional Licensing Unit. In 1993 she became a staff counsel in the Office of the Chief Disciplinary Counsel.

Collection crackdown starts with new policies, list of offenders

The 13th Circuit's crackdown on collection of costs, fines and restitution in criminal cases is gearing up with the adoption of new policies effective July 1 and the internet posting of a list of offenders who can avoid a "warrant roundup" if they pay during a July 7-25 amnesty.

The list of offenders with outstanding warrants for failure to pay or failure to appear for failure to pay is now posted on the Boone County Sheriff's web site at www.showmeboone.com/sheriff/warrants.htm. The list will be revised as people on the list pay what they owe and

their warrants are recalled.

After the amnesty period, the Sheriff's Department and municipal police in Boone County will engage in a concentrated effort to make arrests on all outstanding warrants for those who have not paid.

Under the new policies, most criminal defendants will be expected to pay costs, fines, restitution and criminal victim compensation judgments immediately after sentencing.

Those who ask for an extension of time to pay will be referred to Court Services for a review of their situation. If a

time-payment plan is recommended by Court Services, it must be approved by the sentencing judge. Indigent defendants can be given community service in lieu of payment.

For offenders allowed to pay over time, the new policies specify targets of 50% payment within 48 hours, 80% within 30 days, and 100% within 60 days.

If the governor signs House Bill 600, there will be an additional \$25 surcharge due from defendants whose payment plan extends beyond 30 days. The bill also provides for interception of income tax refunds to pay costs, fines and other courtordered amounts.

The court will continue its policy of not accepting personal checks. Payments must be made by cash, money order or cashier's check. The county is looking into obtaining a automatic teller machine for the courthouse to facilitate cash payments.

Where'd Dave Strauss go?
