05BA, with BA being the code
for Boone County. This will be
followed by a hyphen and then
the case-type code followed by
a number starting with 00001.

Example: 05BA-CV00001 would be the first civil case filed in Boone County in 2005.

From the BCBA President — In Memory of Tom Davis

The new year begins without one of the members of the Boone County Bar. **Tom Davis** lost his year-long battle with cancer Tuesday, Dec. 28, 2004.

I met Tom Davis in the early 1990s when he started as an Assistant Public Defender in Boone County and was assigned to Division Four. As a new attorney (1992 graduate of the MU School of Law), he was immediately responsible for a huge number of files, defending a multitude of defendants with a great variety of charges. It was apparent that he relished his work, that he was prepared for whatever the docket required of him, and that he would step in to help anyone who needed it.

A memorial service featuring a slide show and opportunities to talk about Tom will be held at 7:30 p.m. Saturday, Jan. 8 at The Fieldhouse, 1105 E. Broadway, Columbia.

There were occasions when a non-English speaking defendant would appear for arraignment and it would have to be post-poned to make arrangements for an interpreter. Tom would volunteer to translate in Spanish to make sure that the defendant knew what was happening and when he needed to return to court. I would sometimes see him in the back of the court-room explaining to defendants who did not qualify for a Public

Defender how the criminal process worked. Or if someone had come from a great distance and it appeared the case could be disposed that day, Tom would take the initiative to make that happen. There were so many occasions and ways that Tom went above and beyond the call of duty to serve the public, the courts, and the bar. All the while he maintained an amazing sense of humor and an obvious love for life, his pro-

fession, and his many friends.

Tom was extremely proud to be a founding partner of the law firm **Davis**, **Susan**, and **Holder** in 2000. It proved to be a great career move and a tremendous personal decision. In the past few months, **Bogdan Susan** and **Mike Holder** not only covered Tom's cases in court, they also accompanied him to his doctors near and far, and they were by his side constantly throughout his final days. They give new definition to the term "law partner"

Tom will be missed by those of us who had the good fortune to know him, to work with him, and to be his friend.
