## MoBar President Joe Whisler to speak at March 9 meeting

Missouri Bar President Joe B. Whisler will be the featured speaker at the next regular BCBA meeting at noon on Wednesday, March 9, at Boone Tavern, 811 E. Walnut St.

Meal service will begin at noon March 9 in the large basement meeting room at Boone Tavern. The lunch price will be \$9.

Whisler will discuss several issues the Missouri Bar is confronting this year, including maintaining adequate funding for the courts in a difficult budget year, threats to the Non-Partisan Court Plan, judi-

cial system independence, and availability of the bar's durable power of attorney for health care form.

Whisler will point out that while Gov. Blunt's budget proposal would maintain full funding for the courts, the General Assembly may be tempted to make cuts because the budget appears to be out of balance by about \$240 million.

A shareholder in Cooling & Herbers, P.C. of Kansas City, Whisler focuses on business and commercial litigation, with an emphasis on environmental and aviation matters. He is a 1972 graduate of Southern Methodist University Law School and has been active in bar and civic activities his entire career.

## Court approves 'party information sheets' for case filings

At its Feb. 7 meeting the 13<sup>th</sup> Judicial Circuit Court en Banc approved the use of Party Information Sheets designed by the Office of State Court Administrator to comply with Supreme Court Operating Rule 4.07.01.

Bar members can obtain the forms from the Circuit Clerk's office. The forms also are avail-

able in electronic format on the BCBA web site.

The court encourages bar members to begin filing the forms when filing new cases and will soon make them mandatory. The clerk's office plans to issue a memorandum explaining the use of the forms.

The forms indicate that Social Security Numbers are mandatory, but the clerk's office will not reject filings if SSNs are not available.

In other action, the court:

\* Approved Administrative Order 01-05 amending court costs to correct two errors in the court costs set out in Administrative Order 08-04. The fee for each additional defendant in civil actions was amended to \$20 (from \$21), and the fee for Alcohol and Drug commitment petitions in Boone County was amended to \$75 (from \$95).

\* Approved new procedures for handling after-hours filing of petitions for commitment (mental health and drug and

alcohol). The new procedures closely follow the procedures already in place use for after-hours filing of petitions for orders of protection.

\* Appointed an ad hoc committee to study a proposal from Westlaw for an expanded electronic library. The court has Lexis/Nexis through a state contract.

## Comment sought on GAL fees rule change

Bar members are asked to comment on a proposed change to Local Rule 68.3 which would mandate that parties be required to deposit a sum certain for guardian ad litem fees when a GAL is appointed in family law and juvenile cases.

The change was proposed by the BCBA's Juvenile Law and Family Law committees. The Juvenile Law Committee has

recommended that each party be required to deposit \$750.

Family Court Presiding Judge **Cary Augustine** and Family Court Commissioner **Sara Miller** have asked for comments from bar members before submitting a rule change to the court en banc.
