## Court makes changes to law library

The 13<sup>th</sup> Circuit Court En Banc approved changes to the court's law library at its March 15 meeting. Westlaw service will be maintained, but Westlaw access to AmJur and ALR will be discontinued. The print library in Callaway County will

be discontinued except for Missouri statutes.

The court also approved removal and sale of duplicate sets of VAMS (current through 2000) and Southwest Reporter Missouri cases (current through 865 S.W.2d). Lawyers interested in purchasing the sets should contact **Joy Rushing**.

In other business on March 15, the court dissolved the Mokane Municipal Court at the request of Mokane, which has eliminated its police department and municipal court, and ordered that when an individual is arrested on a capias warrant and then posts bond, the case will be set on the same schedule as "all other bond cases."

## Grimes, 90, retells cautionary tale about new technology in law office

Long-time Columbia lawyer **Phil Grimes**, now retired, recently celebrated his 90<sup>th</sup> birthday. He was surprised with party March 8 at the office of his former partner, **Elton Fay**, and wrote:

"I was honored on my 90<sup>th</sup> birthday by a surprise party at Elton's office, with the help of his wife Nancy, which was attended by nine bar members (**Jim Ausmus, Wally Bley, Judge Larry Bryson, Judge Gene Hamilton, Darwin Hindman, Scott Orr, Judge Gary Oxenhandler, Mal Mayse and Herb Willbrand**) and other friends. Enraged, Bruton jerked the phone off the wall, threw it in the corner, stomped on it, and called Chance to 'come and get the damn thing.'

"But about five months later Bruton contacted Chance and wanted to try phone service again. Chance said he never laughed so hard."
