#### Tip to help prevent identity theft

To help guard against identity theft, family law practitioner **Dave Knight** recommends that when cases are heard in open court, it is preferable not to ask parties to recite their social security numbers but rather to simply ask the parties if their numbers, addresses, etc. are correct as stated in the pleadings.

Family Court Presiding Judge Cary Augustine and Family Court Commissioner Sara Miller have indicated that Dave's recommended procedure is acceptable to them.

However, a larger issue remains—the requirements in statutes and court rules to include social security numbers, birth dates, and other information useful to identity thieves in pleadings readily accessible in open court files which can be reviewed in the clerk's office. It was suggested that the BCBA Family Law Committee take up this issue.

In the meantime, Commissioner Miller indicates that she will seal documents containing sensitive information, such as PIE statements, upon request.

#### Advertising rules program planned

A CLE-credit program on new lawyer advertising rules which take effect Jan. 1, 2006 is being planned by the Executive Committee. Details will be announced in a future *Newsletter*.

The new rules were adopted by the Missouri Supreme Court on Sept. 19 and are available on the court's web site at <a href="https://www.courts.mo.gov/sup/index.nsf">www.courts.mo.gov/sup/index.nsf</a>. On the home page, click on "Orders/Rules" to find the rule.

Maridee F. Edwards, Missouri Chief Disciplinary Counsel, and Sara Rittman, Missouri Ethics Counsel, have issued a joint statement that lawyers will not be subject to discipline for placing advertisements before Jan. 1 which do not comply with the new rules, so long as changes to comply with the rules are made

"as soon as reasonably possible."

The portion of the new rule that has generated the most controversy deals with a requirement that an advertisement contain a conspicuous disclosure reading, "The choice of a lawyer is an important decision and should not be based solely upon advertisements," unless the advertisement is limited to specified information.

Advertisements not requiring the disclosure must be limited to: Name of the law firm and lawyers in the firm; one or more fields of law in which the firm or lawyers practice; dates and places of admission to the bars of state and federal courts; and the address (including email and web site addresses), telephone number and office hours.
