Final photo sittings scheduled Sept. 13

A final photo session for a new BCBA Composite Photo has been scheduled on Monday, Sept. 13, at the Boone County Courthouse, and Friday, Sept. 10, is the last day bar members can schedule a private photo sitting for the composite at the PhotoGliff studio.

So far about 140 members have had their photos taken for the new composite. The last previous composite was done in 2002 and included more than 200 photos.

The final photo session will be held from 10 a.m. to 1 p.m. on Monday, Sept. 13 in the Counsel Chambers located on the second floor of the Boone County Courthouse.

Each sitting only takes only a minute or two, so please stop in when you are at the courthouse on Sept. 13 to have your photo taken. No appointment is necessary.

Members who have not had their photographs taken by Sept. 10 at PhotoGliff's studio or by Sept. 13 at the courthouse will not be included in the new composite.

A large version of the new composite will be purchased by the BCBA to hang in the Counsel Chambers at the courthouse. Also, the composite will be available to members for purchase upon completion, and members may also purchase prints or digital copies of their individual photographs directly from PhotoGliff.

Committee to study defense appointments

BCBA President **Stan Clay** has appointed an ad hoc committee to make recommendations for a local court rule regarding appointment of private counsel to represent indigent criminal defendants should the court find such appointments necessary in the event the local Public Defender's Office declines to accept additional cases.

Committee members are **Tom Schneider**, chair, and **Stan Clay**, **Adam Dowling**, **C.J. Dykhouse**, **Travis Jacobs**, **Kevin O'Brien**, and **Jeff Parrshall**.

An earlier informal gathering of local bar members resulted in a consensus

that any system for appointments to represent criminal defendants should have understandable and fair guidelines and that the pool from which appointments are made should include all lawyers, not just criminal defense specialists. However, some lawyers have asserted that such appointments are unconstitutional.

13th Circuit Presiding Judge **Gary Oxenhandler** has indicated he is staying in touch with the Public Defender's Office to keep abreast of developments and that the court will welcome the bar's input on appointments of counsel for criminal defendants.
