In Memoriam: Sanford "Frank" Conley (1932 – 2017)

The Honorable **Frank Conley** passed away, after a brief illness, on April 11, 2017. He was 84 years-old. Judge Conley began his career in 1962, as an assistant prosecuting attorney in Boone County. He won all 60 Boone County precincts to become a 13th Circuit Judge in 1970, when a second judicial seat was created. In 1979, he was elected presiding judge, and held that position until his retirement in 2002.

Judge Conley is survived by his wife, Carla, and their three children, Brian, Allison, and Ann.

Procedural Changes to Reserving a Bed for 120-Programs Under 559.115 RSMO

If a client is being considered for placement in an institutional treatment program ITC (drug/alcohol treatment, or shock incarceration program), it is necessary to have a reserved bed date. Probation and Parole will automatically screen for these programs where appropriate in sentencing assessment reports and probation violation reports. To reserve a bed date for a client prior to sentencing, you can contact the probation office directly and request a bed date. Probation and Parole will need basic case information (charges, case number, when the client is scheduled to plea or be sentenced, defendant's name, date of birth and social security number).

Requesting a bed date from Probation and Parole does NOT mean that you are agreeing that your client will be sent to the program and does not bind the court in any way. It will possibly save clients from serving additional time in jail waiting for a bed date for delivery to DOC. It will also ensure that clients that are sentenced to 120 day treatment programs actually receive treatment while they are incarcerated instead of spending the time in general population due to arriving with no secured bed date.
