
BCBA members, spouses, children and/or dates are invited to the annual event, which is paid for by the association.

Susan Ford Robertson, who chairs the Missouri Bar Civil Practice and Procedure Committee, is seeking feedback from local attorneys regarding a 2003 legislative proposal to clarify witness fees and mileage for trials and depositions. Statutory changes several years ago resulted in no guidance on the amount of witness fees and mileage. The committee is proposing a \$25 witness fee for trials and depositions and mileage pursuant to \$33.095 RSMo. (the rate approved by the Commissioner of Administration for state employees). The Missouri Bar Board of Governors will consider endorsing this proposal at its September meeting, and Susan needs feedback before then. Call her at 449-2613.

Law Day schedule change announced

The 13th Judicial Circuit has announced changes to the Law Day schedule effective Oct. 1, 2002.

The major change is switching the Division 1 and Division 2 Law Day schedules. That is, starting Oct. 1, Judge Gene Hamilton will have the Law Day schedule that Judge Frank Conley now has, and the new judge of Division 2 will have the Law Day schedule that

Judge Hamilton now has.

Judge Hamilton will be setting the docket and holding court in Boone County on the first Monday and will do the same in Callaway County on the third Monday.

The only other change is that Judge **Joe Holt** (Division 6) will be in Boone County on the second Thursday of each month for contested dissolutions (instead of Callaway County).

Interpreter service contract announced

The 13th Judicial Circuit has entered into an agreement with Culture Guides, Inc. to be a primary provider of foreign language interpreter services in the circuit, said Kathy Lloyd, assistant to the Court Administrator.
