#### Defendants not prepared for costs

Despite the 13<sup>th</sup> Circuit's recent crackdown on collection of costs, fines and restitution in criminal cases, many defendants continue to appear for sentencing unprepared to make payment, says Asst. Court Administrator Kathy Lloyd.

The court is asking defense lawyers to make sure defendants are aware of the new requirements, including the \$25 time payment fee charged when payment in full is not made within 30 days of sentencing.

Legislation effective Aug. 28 increased the standard criminal case costs. Costs for A and B felonies now total \$321.50; C and D felonies, \$299.50; and SIS, \$178.50.

For misdemeanors, costs now total \$101.50; for conservation offenses, \$86.50; and for misdemeanor SIS, \$66.50.

Restitution, fines, recoupment fees and witness fees vary from case to case, and lawyers are encouraged to determine these amounts for their clients.

#### Free mediation program offered on Oct. 3

Boone County lawyers are invited to a free CLE-credit program on attorney advocacy in mediation from 3 to 5 p.m. Friday, Oct. 3 in Room 332 at the MU Law School.

A recently produced video, "Mediation Madness: Advocacy Behaviors in Mediation," underwritten by the ABA Section on Dispute Resolution, will premier as part of the program.

The program is sponsored by the Law School, the Missouri Bar ADR Committee, and the Association of Missouri Mediators. It is designed as a "bridge" event between the Missouri Bar Annual Meeting which ends Oct. 3 and the Missouri Bar ADR Committee meeting on Oct. 4 at the Columbia Ramada Inn.

#### MU Law School has 150 new students

After having larger classes for several years, the MU Law School has downsized its first year class back to 150, reports Dean Larry Dessem.

Women constitute 46% of this year's new students, 85% are Missouri residents, and 11% are minorities. The new students' average undergraduate grade point average is 3.45, while their average LSAT scores place them in the top 27% of

students nationally.

Just over one-third of the new students have undergraduate degrees from MU, while 13 are from Truman State and six each are from Southwest Missouri State University and St. Louis University.

While many of the new students came directly from undergraduate studies, the class also includes an M.D., a dentist, and a former airline pilot.
