Bill Atkinson: 1944-2003

Long-time Columbia lawyer Bill Atkinson, 59, died of a heart attack on Nov. 15, 2003. Among the survivors is his wife Charlotte Atkinson, who was his law partner in the firm of Atkinson & Atkinson.

Bill was born Feb. 24, 1944. He attended Normandy High School and received a bachelor's degree from MU in 1968, the same year he helped organize the Boone County Ambulance Service. He was awarded his law degree from MU in 1971. He was BCBA President in 1996-97. Bill is also survived by two daughters, his mother and a brother.

About 30 BCBA members attended a memorial service for Bill on Nov. 20.
