Courthouse expansion tax proposal on April 4 ballot

The Boone County Courthouse expansion project is moving forward with a tax proposal, and bar members are urged to provide their input on the project to members of the Bar Expansion Committee, which will meet in early February.

Committee members are **Bruce Beckett**, **Wally Bley**,

C.J. Dykhouse, **Pat Eng**, **Elton Fay**, **Marsha Fischer**, **Dave Knight**, **Susan Ford Robertson**, and **Loramel Shurtleff**.

The Boone County Commission voted in January to place a capital improvements sales tax proposal on the April 4 ballot. The 1/5 cent sales tax would fund courthouse expansion and

other county capital projects and expire after four years.

A similar tax initiative was undertaken in 1986 for the renovation of the courthouse and relocation of the jail. At that time the courthouse annex was designed to accommodate additional floors. The current plan calls for adding two floors to the courthouse annex.

Retired Circuit Judge **Frank Conley** and **Joe Moseley** will co-chair a committee supporting the initiative. Committee members will be available to speak at meetings. To arrange a speaker, contact the Court Administrator's office at 886-4060.

CLE credit for free bankruptcy symposium

Nationally recognized legal scholars will visit the MU Law School Feb. 24-25 to discuss the most sweeping bankruptcy law changes passed by Congress in more than 25 years.

Topics to be discussed will range from the role of race in bankruptcy reform, to using social science research to test the assumptions underlying bankruptcy reform, to the impact of means testing on the bankruptcy system.

Jan. 1 rule changes affect civil practice

BCBA members are reminded of some new Missouri Rules of Civil Procedure effective Jan. 1, 2006 which will affect day-to-day practice.

Rule 43.01(c) now requires that pleading signature blocks include mailing address, phone and fax numbers and **email address**. The rule also allows service to an email address of any attorney or party who has filed a consent in the case in substantially the form of new Civil Procedure Form 17.

Rules 57.01, 58.01 and 59.01 now require that interrogatories, document requests and requests for admissions be served on the responding party in an **electronic format** readable by Word or WordPerfect on diskette, on CD or by email, in addition to the continuing requirement that paper copies be served on all non-defaulting parties. The certificate of service must state the format of the electronic copy and the medium used to transmit it to the responding party.
