The Boone County Commission has placed a 1/5-cent capital improvements sales tax proposal on the April 4 ballot to fund courthouse expansion and other county capital projects.

Rule fuss leads to procedure change

The recent fuss over the 13th Circuit's new cell phone and pager rule apparently will not lead to any change in the rule, but did result in changing the court's procedure for adopting new rules.

Responding to complaints that details of the proposed cell phone rule were not made available for comment before the rule was adopted, Presiding Judge Gene Hamilton proposed Local Rule 100.2, which provides that all local rule changes will go into effect 60 days after passage unless a change is adopted with an emergency clause. The proposal was passed by the Court En Banc on Feb. 6.

Judge Hamilton explained that after future rule changes are ------ passed with a delayed effective date, they will be circulated to the local bar for comment. which is specifically provided for in the rule.

Associate Circuit Judge Jodie Asel, immediate Past President of the BCBA, was instrumental in bringing to Judge Hamilton's attention the bar's desire to be able to comment on proposed rules before they take effect.

In keeping with proposed Rule 100.2, it will not go into effect until April 7. Therefore, it does not yet appear on the BCBA web site.

However, the cell phone/pager rule is now posted on the web site, along with the updated master Word document containing all local rules. _____

Callaway Courthouse security statement

Bob Sterner, Callaway County Prosecutor and chair of the Callaway County Courthouse Security Committee, has issued a statement about courthouse security for lawyers who do not routinely practice there. He said:

"Much of what goes on in court is stressful for the parties, and sometimes that stress may lead to inappropriate and even dangerous behavior. Parties' lawyers are in a better position to anticipate problems than the courthouse mar-

shals.
