## What's Your ADR I.Q.? From the BCBA

ADR Committee

For those of you in civil practice, this month's note provides some information on both arbitration and mediation.

There is a common myth among litigators that that arbitrators simply "split the difference" between the parties in making an award. A number of studies have shown that this is not the case.

One recent study, undertaken by the AAA on 2007 Construction arbitration awards, found that in only 9%, or 54 of the 574 cases studied, were awards in the midrange or split down the middle, while in 43% of the cases awards were more than 80% of the claims and in 13% of the cases claims were totally denied. Also in 2007 the ABA Section of Dispute Resolution Task Force on Improving the Quality of Mediation issued its final report on improving mediation quality in private practice civil cases.

Some interesting findings for advocates: One theme that emerged in interviews with parties was that lawyers should be as prepared for mediation as they are for trial. Also, although only a minority of lawyers objected to a mediator stating their opinions about settlement terms, a majority of the parties found mediator comments about what they should offer or accept objectionable. The report is interesting reading on many levels and is available through our ADR committee.
