## **Electronic filing CLE program reset for June 9 meeting**

Because the May 12 BCBA meeting was cancelled after the collapse, and subsequent death, of MU Law School Associate Dean **Jim Devine**, the June meeting will feature the same program originally scheduled in May.

"The Future of Electronic Case Filing in Missouri" will be the 1.2-hour CLE-credit topic of Catherine Zacharias, Legal Counsel for the Office of State Courts Administrator, at lunchtime on Wednesday, June 9.

As an experiment with a different meeting location, the meeting will be held in the Ballroom at the Tiger Hotel, 28 S. 8th St., Columbia.

Also featured at the meeting will be a recognition of **Ron Smull** by a representative of the MU Law School for Ron's 35 years of service to the school. He had taught the Legal Drafting class since 1975.

As in May, the meeting was arranged and will be hosted by the

BCBA Young Lawyers Committee. Meal service, provided by Tiger Hotel Catering, will begin at 11:30, with the CLE presentation starting at noon. As always, the price will be \$9, payable at the door. If paying by check, make checks payable to "Tiger Hotel."

Ms. Zacharias has been working on Missouri's electronic filing program for more ten years at the Office of State Courts Administrator. Next year, the Missouri Supreme Court will conduct a pilot program of the system. Thereafter, electronic filing will rolled out to the appellate and circuit courts. At first, electronic filing will be voluntary, but is expected to become mandatory.

Her presentation will provide both an overview of how the electronic filing system will work and an explanation of how the system will affect every Missouri lawyer in the coming years.

### June 11 meeting set on PD notice

Local private criminal and civil law attorneys are invited to a meeting organized by the BCBA Criminal Law Committee from noon to 1 p.m. June 11 at the Boone County Government Center to discuss the possibility of court appointments to represent indigent criminal defendants.

As recently reported in *Missouri Lawyers Weekly*, the Boone County Public Defender's Office is among 10 such offices statewide which have given notice that they may start turning down cases pursuant to a December Missouri Supreme Court ruling that entire offices can be closed to new

cases when they determine they cannot effectively represent any more new clients.

Discussion topics at the June 11 meeting will include discussion of the meaning of the local office's notice, the structure of an appointment system should the court need to start assigning attorneys to represent indigent criminal defendants, and options that may be available to appointed attorneys.

Civil law attorneys are welcome and may want to attend because they possibly could be appointed to represent criminal defendants, said Criminal Law Committee Chair Kevin O'Brien.

#### **JIM DEVINE - 1948-2010**

MU Law School Associate Dean **Jim Devine** collapsed at the May 12 BCBA meeting just before it began and subsequently died of a heart attack. During his 30 years at the Law School, he touched the lives of many local bar members. An obituary accompanies the online version of this story.

We are proud of the rapid response to Jim's collapse by bar members at the May 12 meeting (which ended up being cancelled). They promptly summoned emergency services and began CPR efforts.

According to a recent CBS News report, brought to your Editor's attention by **Bruce Beckett**, most modern digital photocopiers contain a hard disk which can store thousands of document images.

Therefore, when your office disposes of a copier, a technician should be engaged to remove or completely erase the hard disk. Many used copiers are refurbished and resold, so failure to remove or erase the hard disk could result in copied documents falling into the hands of third parties.
