

# Electronic Filing for Missouri Courts

For many years, Missouri's judicial leaders have discussed the creation of a system for filing court documents electronically. We have come to understand that a paper-driven system is slower, more expensive and quickly becoming outdated. An electronic filing system for the courts will allow court clerks and attorneys to be more efficient by reducing time and effort while offering more options. In today's world, both court users and the public expect access to court files to be almost immediate – often before the courts have been able to process the information. But the amount of time required to transfer information from paper records to the court's case management system is extremely time-consuming. And with a paper file, only one person is able to access the information at a time.

An eFiling project team determined that a basic eFiling system could be voluntarily implemented by attorneys and courts, could provide a method for development and testing of a later developed, full-scale eFiling application, could be deployed statewide before improvements or upgrades were made, and could enable the development of Supreme Court rules pertaining to eFiling. The managers of both successful and troubled electronic filing projects around the country have recommended that rules for electronic filing be in place *before* pilot testing of a system takes place. The Supreme Court rules to be established before implementation include:

- Establishment of the electronic file as the official court record.
- Establishment of the hours of “business day” and how they apply to the extended hours of an electronic filing system for the purposes of meeting statutes of limitations and court rules.
- Establishment of when the electronic filing is officially received.
- Definition of who has access to the electronic case file and how.
- Fees associated with electronic filing on either a case basis or subscription basis.
- Court rules may require mandatory participation in a case.
- What is a signature.

The basic eFiling product will be of minimal cost to the judiciary as well as cost-effective for attorneys. It will improve access to the courts by eliminating geographic barriers and providing after-hours case interaction. It will increase efficiency and reduce processing times in case filings to combat shrinking personnel resources and budget cuts through technical integration between the Justice Information System (JIS) and eFiling. It will eliminate delays in retrieval of case records due to lost or checked-out files. It will maximize technical integration between the eFiling product and the existing JIS environments by placing technical integration under the direct control of the OSCA Information Technology (IT) Division.

The eFiling system will deliver filings to the court in the appropriate form and format, appropriately collect fees and costs associated with the filing and delivery to the court, provide access by case attorneys to case records, and process incoming electronic filings through a clerk review queue to edit as necessary and commit to JIS or reject back to the filer with an explanation. It will docket and schedule case filings within JIS automatically using integrated data transfer, reduce the physical handling of paper case documents and duplicative data entry

required to make case filings, provide secondary service (notification) electronically, and provide a single application for clerks to use to initiate cases and include the existing processes of initial criminal case filing, highway patrol ticket transfer, Fine Collection Center ticket transfer, and mass civil case loading.

The basic eFiling system will only be available to Missouri licensed attorneys and will only allow filing in public cases. Registered users will be able to view any electronic documents that are filed in open cases. The eFiling system is not public access to the courts.

The Supreme Court and the 11<sup>th</sup> Judicial Circuit (St. Charles County) will pilot the eFiling system, with implementation in the three appellate district courts immediately following. The application will be provided statewide after the pilot, with an implementation planning team determining the future rollout sequence. Future enhancements will be added, as time and resources permit, once the system has been in operation for a period of time.

Electronic filing of court documents represents a dramatic change in the legal culture, and the stakes are high. But new technology will continue to be necessary if we continue to see a growth in litigation. The success of the project will depend on the willingness of you who use it, but ultimately will be judged by how well it serves the process of justice itself.

# eFiling – It's been a long time coming

- Began the vision for eFiling when the Judiciary made the decision to have statewide case management system
- 2008 the last court went on JIS
- 2008 issued an RFP for eFiling
- 2009 MCA recommended that the eFiling system be built by OSCA

# eFiling – The Vision

- Deliver documents to/from the court electronically
- Integrate information into the court's CMS
- Electronic service
- Ability to review documents remotely

# eFiling – The Timeline

- Design began November 1, 2009
- 18 months for design, coding, testing and implementation to the pilots
- Stakeholder meetings

# eFiling – We need Rules

- The Supreme Court appointed a eFiling Rules Task Team of the MCA
- Rules are being developed to facilitate eFiling
- Rules will be reviewed by MCA, Civil and Criminal Rules



# eFiling – We need Rules

- Establish the electronic file as official court records
- Establish business day as 11:59 pm
- Establish the date/time received
- Define signature
- Mandatory/Voluntary

# eFiling – How do we pay for it?

- Subscriber fee?
- Filing fee/surcharge?
- NOT a transaction fee
