# Clerk stops sending return date notices

The Boone County Circuit Clerk's office has stopped sending return date notices to attorneys when summonses have been served in associate civil cases.

Circuit Clerk Christy Blakemore said the change is a cost-saving measure necessitated by budget cuts and made possible by the fact that lawyers can obtain return dates from Case.Net or from their private process servers. She said the majority of other circuits have already stopped sending such notices.

Notices will still be sent to lawyers when a summons is returned non est and when a sheriff charges for additional mileage.

eligible for the "Children In Crisis Tax Credit". For example, a donation of \$1,000.00 results in a tax credit of 50% and a federal tax deduction of 28%, with the result that the actual cost to the donor is only \$220.00.
