Food banks nationwide are continuing to struggle to feed hungry people in this difficult economy, so the BCBA Holiday Party on December 12 has been designed to help our local Food Bank again this year, at the same time as we enjoy this annual social gathering with other lawyers and judges and their spouses and dates.

The party will be held from 6:00 to 8:00 p.m. on Wednesday, December 12 at the Columbia Country Club, 2210 Country Club Dr. Spouses and dates are invited and welcome.

The format will be a mixer with heavy hors d'oeuvres. There will be a host bar providing soft drinks, beer and wine. Mixed drinks will be available for purchase. There will not be live entertainment this year, with the extra funds going to ensure that there will be more food. A very brief program will take place at 7 p.m.

The Food Bank collection will help us focus on giving to others in the holiday spirit. The Food Bank helps feed about 121,000 people in central and northeast Missouri identified as "food insecure". **Norm Lampton** is in charge of the food drive, which will work like this:

- ! We're asking each person to bring about \$5 worth of non-perishable food items to the party -- packages, bottles, cans. Norm has arranged for The Food Bank to provide and pick up six collection bins. If you bring food, your admission price will be \$20 per person.
- ! If you prefer not to bring food or cannot do so for some reason, your admission price will be \$25, and the bar will donate \$5 to the Food Bank on your behalf.

- Canned vegetables
- Canned fruit
- Canned meats such as tuna, chicken or beef
- Canned soup
- Boxed meals such as Hamburger Helper
- Pasta or rice
- Hot and cold cereal
- Peanut butter and jelly

Last year, a total of 116 bar members, spouses and guests attended the Holiday Party, and brought with them a total of 262 pounds of food and \$365.00 to donate to the Food Bank. Even with the Food Bank contributions, the cost of this year's Holiday Party is a bargain. The per-person cost in previous years has been as much as \$35.

You can pay at the door. However, if you RSVP but end up not being able to come, we will still need for you to pay since the bar will have to pay the Country Club based on the number who made reservations.

We hope to see an even larger attendance this year so we can have a great turnout and a fantastic collection for the Food Bank!

## **Revised Assignment of Counsel Protocol Effective November 8**

On November 8, Presiding Judge **Gary Oxenhandler** signed Administrative Order 12-12 – Revised Assignment of Counsel Protocol, which became effective immediately to repeal Administrative Order 09-12 and provide an updated guide to the Court, Clerks and Counsel to ensure that indigent defendants facing incarceration are represented by counsel. #### 13th Judicial Circuit Announcement for Mediators

The 13th Judicial Circuit is now accepting applications for their 2013 list of Court-Approved Family Court Mediators. Supreme Court of Missouri Rule 88.05 requires a mediator in a contested child custody matter to be an attorney or to possess graduate degree in a field that includes the study of psychiatry, psychology, social work, counseling or other behavioral science substantially related to marriage and family interpersonal relationships. This rule also mandates that a mediator has received a minimum of 20 hours of child custody mediation training in a program approved by the court.

Applicants must submit an application form and certificate of completion of hours taken. The 13th Circuit's Local Court Rule 68.12(C) notes that "Annually, mediators who wish to remain on the list shall update the court administrator regarding any continuing education completed during the year. It is expected that mediators will maintain and develop mediation skills by attending a minimum of six hours of mediation related training every two years using The Missouri Bar's reporting period."

We have already realized the time savings from not looking for and pulling files. Our Judges are now using eBench and they are using electronic means to make their docket entries. This too has decreased the time to process their orders into JIS which means the information is available in Case.net in a timelier manner.

As of this date we have received 696 filings and we have rejected only 27. We are making every effort to contact you and to accept cases without rejecting them. When documents are received without signatures or if pages are missing, we must reject them and I hope you understand.
