# Judge Asel Elected to be 13<sup>th</sup> Circuit Presiding Judge

The following Press Release was sent by email on January 16:

The 13th Judicial Circuit Court en Banc met yesterday, January 15, 2013, and elected Judge **Jodie Capshaw Asel**, Circuit Judge, Division IV, to serve as Presiding Judge effective Thursday, January 31, 2013. Judge Asel will succeed Judge **Gary Oxenhandler**, who served as Presiding Judge from March 2010 until present.

Judge Asel, was first appointed to the court in 1991, and has been elected since 1992. She was elected Circuit Judge of Division IV in 2006. Division IV handles general civil and criminal dockets. Judge Asel is a graduate of the University of Missouri - Columbia, School of Law, with an undergraduate degree from the University of Missouri - Columbia.

Prior to appointment to the court, she was an Assistant Prosecuting Attorney for Boone County; Assistant Public Defender; and in private practice. Judge Asel has served on the Missouri Supreme Court Judicial Education Committee since 1993, and has been Vice Chair since July 2009. She has been a member of the Coordinating Commission for Judicial Education since 2008. Judge Asel was previously a member of the Board of Directors of the Missouri Association of Probate and Associate Circuit Judges for five years, serving as its Vice President and President. She served as President of the Boone County Bar Association from 2004 - 2005. She has served as an officer of the Missouri Circuit Judges' Association for the past three years and is currently serving as President. Judge Asel resides in Columbia with her husband Don Asel. They have three daughters.

# **Changes Made to Boone County Probate Court Fingerprinting Procedure**

The following is a message from Sandra Oswalt, Probate Supervisor:

Please be advised that fingerprints can be done at the courthouse with the Court Marshal's on Tuesday, Wednesdays and Thursdays from 9:00 a.m. to 4:00 p.m. However, if it is a Tuesday following a Monday holiday, we ask that you not send anyone for fingerprints on those Tuesdays as they are very busy days.

Your clients will need their receipt showing payment has been made for the fingerprints with them when they come in or we can get them a copy in the probate office. No appointment required, they can either stop at the Marshal's station on the 1st floor of the courthouse or they can come to the probate division and we will contact the Marshal's for them.

No fingerprints will be done on Monday's or Friday's as these are usually extremely busy days in the courthouse and there is usually not a Marshal available to process the prints. An exception can be made on Monday's or Friday's if you have an out of state client or a client that has traveled some distance for court and they are only going to be here on that day.

1. Courthouse Wireless Access:

As a courtesy to attorneys, wireless internet access is available in most public areas of both the Boone and Callaway County courthouses. Access requires logon credentials provided by the circuit's Technology Services staff. Credentials may be requested by contacting Technology Services staff by email. Please be sure to identify the desired courthouse(s) where wireless access is desired.

Staff who already have logon credentials and wish to change their password may do so by contacting Technology Services staff by email and requesting the change.
