New Waiver of Preliminary Hearing Form on the 13th Circuit's Website

The Court en Banc approved a new waiver of preliminary hearing form at the meeting on September 23. The form is posted on the court's website

(http://www.courts.mo.gov/hosted/circuit13/forms/CRIMINAL_WaiverOfPreliminaryHearing.pdf). At the bottom of the form, there is an "Instructions to Filer" requesting that the attorney designate the defendant's location if in custody and whether the circuit court arraignment should be set on a court docket, on a video docket or if a circuit court arraignment waiver/plea of not guilty form will be filed.

Also, a reminder about the circuit court arraignment waiver/plea of not guilty form. If your client intends to plead not guilty at arraignment and there are no other pending matters to be taken up at arraignment, it saves time for everyone if the form is used. The forms are available in the courtrooms and can be filed in court with the associate circuit judge after a preliminary hearing or waiver of preliminary hearing.
