# **Announcement for Court-Approved Family Court Mediators**

The 13th Judicial Circuit is now accepting applications for their 2017 list of Court Approved Family Court Mediators. Supreme Court of Missouri Rule 88.05 requires a mediator in a contested child custody matter to be an attorney or to possess graduate degree in a field that includes the study of psychiatry, psychology, social work, counseling or other behavioral science substantially related to marriage and family interpersonal relationships. This rule also mandates that a mediator has received a minimum of 20 hours of child custody mediation training in a program approved by the court. Local Court Rule 68.16(C) requires mediators to obtain an additional 6 hours of mediation-related training every two years, using The Missouri Bar's reporting period. Applicants must submit an application form and certificate of completion of hours taken. Please submit your completed application by December 30, 2016 to Cindy Garrett, Deputy Court Administrator, 13th Judicial Circuit, Boone County Courthouse, 705 E. Walnut St., Columbia, MO 65201. ## Missouri Supreme Court Judge Richard B. Teitelman Passes at Age 69

It is with great sadness that the Supreme Court of Missouri acknowledges the passing of its beloved colleague, Judge Richard B. Teitelman, on November 29. Judge Teitelman began his service on the state's high court in March 2002 and served as its chief justice from July 2011 through June 2013. In honor of Judge Teitelman, the Supreme Court cancelled oral arguments scheduled for November 29. Judge Teitelman's funeral was held Thursday, December 1, in St. Louis. Memorial contributions may be sent to Legal Services of Eastern Missouri, 4232 Forest Park Avenue, where he served for almost 25 years.

### **Update to Local Court Rules**

At the October 25th Court en Banc meeting, Local Court Rule 6.1.1 was updated to remove the language regarding requests for jury trials going to circuit court. Effective January 1, 2017, associate circuit judges will hear jury trials. The docket schedule is being updated to provide each judge with time to hear jury trials.

At the same meeting, the Court en Banc approved rule 6.11 "Assignment to Probate Division," which allows matters under local court rule 4.3 to be transferred to the probate division by any judge. This was passed with the emergency clause to be in effect after 30 days so that it, and rule 4.3, are in effect at the same time. Rule 4.3 was passed in the September Court en Banc meeting.

# Missouri Bar Cards Now Required for Attorneys to Bring Phones into Courthouse

At the August 23, 2016, 13th Circuit Court en Banc meeting, the court amended Local Court Rule 9.6 Electronic Devices, to prohibit the public from bringing cellular phones into the Boone County Courthouse, and into the Callaway County Courtrooms. This policy will go into effect on Monday, October 24, 2016.

This amendment has been discussed by the Court en Banc since its May meeting, though the Court Marshal office has made the request in the past.

The change was proposed and considered in light of local and national concerns with security. This policy is not unique to the 13th Circuit. At least 14 other state courts in Missouri have the same or more restrictive policy, and the public are not allowed to bring their phones into the Supreme Court of Missouri; the Missouri Court of Appeals, Western District; and some federal courthouses.

The amendment passed unanimously by the Court en Banc states that no one is allowed to bring a cell phone into the Boone Courthouse or a Callaway courtroom with exceptions for work related duties. Callaway was limited to the courtrooms only, as it is a multi-function building. Work related exceptions include attorneys, law enforcement on official duty, and the media; but only attorneys may use their phones in the courtroom. An important caveat to the list is in section 6 which allows "Any other person the court may authorize."

The amendment includes the following new language:

- A. No persons are allowed to bring cellular telephones into the Boone County Courthouse, or the Callaway County Courtrooms with the following exceptions:
  - 1. Attorneys in good standing.
  - 2. State and county employees on court business.
  - 3. Law enforcement personnel and Probation and Parole Officers on official duty.
  - 4. Victims/witnesses who are attending court business in the

Prosecuting Attorney's Office and the Juvenile Office.

- 5. Members of the press.
- 6. Any other person the court may authorize.

Any person in the categories above may be required to provide identification to confirm their status upon the request of the Court Marshals. Persons allowed to bring cellular phones into the Boone County Courthouse are not allowed to use them in the courtrooms. Attorneys, who show their MO Bar Card upon entry, are allowed to bring cellular phones into the courtrooms and are requested to restrict use of their cellular phones in the courtrooms to business only.

# Attorneys and Law Students Needed January 15-16 for Mock Trial Tournament

Columbia College and the University of Missouri Columbia are hosting an Undergraduate Mock Trial Invitational Tournament competition at the University of Missouri Columbia on Friday January 13 and Saturday January 14, 2016. The tournament hosts need attorneys and law students to serve as judges for this four-round tournament, which serves as a forum for teams to practice their skills for the regional tournament held in Kansas City in February. Judges will score a printed ballot with established criteria and rule on evidentiary objections governed by an evidence code similar to the Federal Rules of Evidence.
