Presiding **Judge Kevin Crane** signed Administrative order 11-18 effective August 28, 2018 updating court costs and fees. Also, effective August 31, 2018, there will be a \$3.50 Juvenile Justice Preservation Fund fee assessed on all civil cases pursuant to 488.315 RSMo. Other changes that will be reflected include an increase to certified mail from \$11.05 to \$12.00. Also, when filing guardianship and conservatorship of minors, separate cases must be filed for each minor, however only a single filing fee is necessary to cover the costs of all sibling cases filed in the same day. A note to the clerk should be included indicating the names of the sibling cases.
