OTHER NEWS

Christine Stamper biked and ran her way to a second place age-group finish in the 37th Annual Memphis in May Triathlon on Sunday, May 19th. The event consisted of a 1500 M swim, 40K bike and 10K run.

On May 21, 2019 the Court en Banc approved changes to Rule 69.3 to be in compliance with changes to the Local Violations Bureau by adding language from Supreme Court Rule 37.49 and 38.10, along with a sample order that can be used to comply with the rules. The language added to Rule 69.3 is "E. Each judicial circuit shall establish by court order a circuit violations bureau in each county within the circuit. F. Any judge having original jurisdiction of any animal control violation, housing violation, or traffic violation may establish by court order a local violations bureau, which shall be subject to the supervision of the circuit court. A sample order pursuant to Supreme Court Rule 37.49 is noted below." Changes to Local Court Rule 69.3 will become effective on July 21, 2019.

Based on Commissioner Casey Clevenger's goal of making treatment court eligibility objective and transparent, a new eligibility checklist is planned to be implemented on June 1, 2019. Going forward, when the court orders a screening, treatment court staff will use this checklist to easily and objectively determine if someone is eligible for treatment court. This meets one of the goals of the federal grant the court has for equity and inclusion. Commissioner Clevenger has met with OSCA, Judge Carpenter, prosecutors in Boone and Callaway counties, private counsel, and the public defenders in Boone County regarding the eligibility checklist as well has having consulted with a group from American University in Washington D.C. It is anticipated this will make more people eligible for treatment court. The checklist will soon be made available to attorneys and the public on the 13th Judicial Circuit's website.

Commissioner Clevenger announces that attorneys or defendants have one week from the date the screening is ordered to contact the Treatment Court Center and arrange for the screening. Failure to contact the Treatment Court Center within one week of the order could result in a determination of ineligibility.
