# In Memorium: Edward William "Bill" Brandecker (1921- 2020)

On January 2, 2020, **Bill Brandecker** passed away peacefully in his home at the age of 98. Excerpts from his obituary follow:

Bill was born in Marshall, Missouri, and was the only child of Clara and Edward Brandecker. He served in the Air Force in World War II, and was distinguished with the Distinguished Flying Cross for his heroic service in the line of duty when he returned his crew from a mission despite the loss two engines and inclement weather.

Bill married Betty Hinnenkamp on November 30, 1946, and was married for 53 years before her death in June 2000. He graduated from University of Missouri Law School in 1950, and served as an assistant prosecuting attorney before opening his own law practice that lasted over 60 years in Columbia.

Services include a funeral prayer vigil at 4:30 p.m. Friday, Jan. 10 at Our Lady of Lourdes Church, 903 Bernadette Drive, with family receiving visitors there from 5 to 7 p.m. A mass of Christian burial will begin at 11 a.m. Saturday, Jan. 11 at Our Lad y of Lourdes Church, followed by a military service at Columbia Cemetery concluding with a luncheon for all guests at the church.

## Mid-Missouri Mock Trial Invitational Tournament January 18-19

Columbia College and the Board of Advocates at the University of Missouri-Columbia Law School will host the Mid-Missouri Mock Trial Invitational tournament on Saturday, January 18 through Sunday January 19, 2019. We began hosting AMTA events in 1999 and we look forward to our 22nd year of hosting. This is a four round, two-day tournament which is limited to 28 teams.

The tournament hosts need attorneys to serve as Judges for this four round Tournament, which serves as a competitive forum for teams to earn bids to the National Championship tournament. Judges will score a printed ballot with established criteria and rule on evidentiary objections governed by an evidence code similar to the Federal Rules of Evidence. There are 28 teams from Colleges in the region attending this event. This year's case is a criminal case, with a fact pattern involving homicide. Judges are needed for any and all of the rounds, which begin Saturday at 9:00 a.m. and 2:00 p.m. and 8:30 a.m. and 1:00 p.m. on Sunday.
