

State of the Court Address held on December 2

The annual State of the Court Address was held virtually via Zoom at 12 p.m. on Wednesday, December 2, 2020. Judge Kevin Crane provided information to attendees on changes, challenges, and updates related to the 13th Circuit Court. Municipal Court Judge Cavanaugh Noce also provided information about Columbia Municipal Court's changes and efforts throughout the COVID-19 pandemic. 113 people joined the virtual address.

New Co-Occurring Court added to Treatment Court options

On Monday, November 23, 2020, Commissioner Casey Clevenger held the first Co-Occurring Treatment Court in Callaway County, as an expansion of the Drug Court, in collaboration with the Arthur Center.

"There has been a need for access to mental health treatment for those involved in the criminal justice system for a very long time," Clevenger said. "This will better address both the substance use and mental health needs of our Drug Court participants. As with all of our treatment courts, the goal is to stop the cycle of substance use – sometimes used as self-medication – and to get participants into stable housing and jobs to support their families."

Participants referred to this court will be assessed by the Arthur Center and those with "co-occurring" substance use and mental health diagnoses will be able to get mental health treatment. This will include access to psychiatric care, medication, and case management, in addition to the support and requirements of all treatment courts.

"Through our Treatment Court team members we were able to brain-storm ways to expand the courts that already exist here," Clevenger said. "The Fulton Police Department helped us foster a relationship with the Community Mental Health Liaison from the Arthur Center, they were integral in getting the pieces in place to move forward for this court. This court will create a greater opportunity for success with access to proper diagnosis and medication."

Callaway County's Treatment Court is one of more than 3,000 nationwide annually serving more than 150,000 people. Treatment Courts are now the most successful justice program for reducing addiction, crime and recidivism while saving taxpayer dollars. Treatment Court graduates enter the program addicted to drugs and often facing long term incarceration, but because of the combination of accountability and treatment, they become enrolled in school, reunited with their families, employed, and paying taxes.
