The link to the Zoom meeting will be distributed in advance of the presentation.

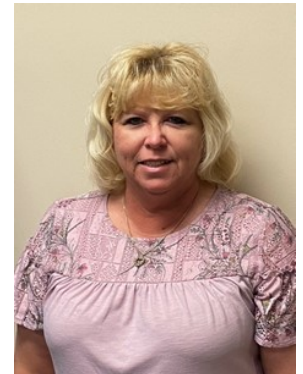
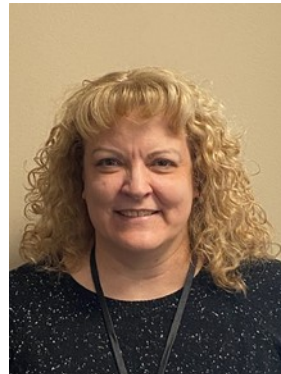


Boone County Circuit Clerk's Office Recognizes Employees Missy Marlett and Michelle Cecil

12th Circuit Court Offers Domestic Relations Mediation Training

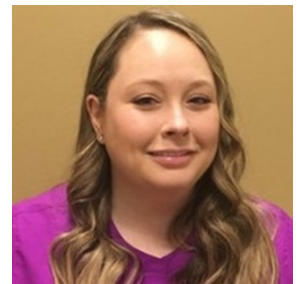
The 12th Circuit recently established a mediation program for domestic relations cases within the circuit. Through funding from the Domestic Relations Resolution Fund grant program, the Circuit is able to help offset costs of mediation. This will help to provide opportunities for parties to actively resolve their cases expeditiously, reduce litigation costs, and it will provide a needed tool to help reduce the COVID backlog of cases. The 12th Circuit is also pleased to be able to use this funding to sponsor Rule 88 required training for interested individuals who are willing to be on the 12th Circuit mediator list. The 40-hour training will be conducted virtually, over two weekends: April 16, 17, 18 (Part I - Basic Mediation Training) and April 23, 24, 25 and 26 (Part II- Family Law Mediation Training). Each registrant would be responsible for a cost of \$400 per registrant. The training has a maximum limit of 12 participants and members of the bars in surrounding circuits are invited to attend if interested and willing to be placed on the 12th Circuit's mediator list to accept assignments. Please note that registrations will be accepted in the order they are received, and once the class reaches 12 participants registration will be closed.
