13th Circuit Court Updated COVID-19 Regulations

A new COVID-19 Order in the 13th Circuit went into effect on Wednesday, June 2. The new Order states (1) that the presiding judge will continue to exercise discretion to determine which precautionary measures should be used within the courtroom, (2) that vaccinated individuals will no longer be required to wear face coverings or observe social distancing within court facilities, while non-vaccinated individuals are still required to do so, (3) each division presiding over a case or courtroom will have discretion to decide if any precautionary measures are still necessary in the courtroom, (4) vulnerable participants may still appear remotely, (5) the circuit will continue utilizing teleconferencing and video-conferencing where appropriate, (6) judicial employees may travel for work-related functions and court committees can resume in-person meetings, and (7) judicial employees should still alert supervisors if they are in close contact with someone who has tested positive for COVID-19. Missouri Bar Approves BCBA and 13th Circuit Technology Grants

The Missouri Bar Board of Governors approved grant applications for the Boone County Bar Association and the 13th Circuit technological equipment or projects related to the COVID-19 pandemic. The BCBA will use the grant funds to purchase two computers with video-conference capabilities, and a multi-function printer for the attorney work room/lounge at the Boone County Courthouse. At the Callaway and Boone County Courthouses, the 13th Circuit will use the grant funds to purchase mobile carts for the videoconference units so they can be move between the courtrooms and to improve the video feeds.
