Boone County Treatment Courts Praised for Inclusivity

On August 17, 2021, the National Association of Drug Court Professionals named Boone County, Missouri, as the recipient of the 2021 NADCP Equity & Inclusion Award.



This award is given annually to celebrate the accomplishments of a treatment court program that plays a significant role in improving service across diverse populations, eliminating cultural disparities, and ensuring inclusion.

In front of 4,500 treatment court professionals, judges, counselors, and law enforcement at the NADCP national conference in Washington DC, the NADCP Board of Directors praised Boone County, Missouri's 13th Judicial Circuit, and Commissioner Casey Clevenger for the good work being done in central Missouri.

Commissioner Casey Clevenger, who presides over Boone County's five treatment court programs, said "The Boone County Treatment Court has always been open to change when the data shows a need for improvement. This team has worked hard to expand access to treatment and improve outcomes for African Americans in the criminal justice system in Boone County. It was an honor for NADCP to recognize that work."
