


### **BCBA Holiday Party Scheduled for December 8**

## Mid-Missouri Mock Trial Invitational set for January 22-23, 2022, Looking for Attorneys to Serve as Judges

Columbia College and the Board of Advocates at the University of Missouri Law School will host the Mid-Missouri Mock Trial Invitational tournament on Saturday, January 22 through Sunday, January 23, 2022. The group began hosting AMTA events in 1999 and looks forward to their 24th year of hosting. This is a four round tournament which will have 28 teams. The tournament will be conducted in person at the Law school and adjacent



buildings. This year's case is a criminal case. Volunteer attorneys are needed to serve as judges for the tournament. Judges will score a ballot and rule on evidentiary objections governed by an evidence code analogous to the Federal Rules of Evidence. Judges are needed for all rounds,
