



CLE Planned for in-person February 9 BCBA Meeting



The February meeting of the Boone County Bar Association will be in-person at the Columbia Country Club and will feature a CLE presentation by Assistant County Counselors **Jennifer Rodewald** and **Stacy Vincent**, attorney **John Whiteside**, and Presiding **Judge Brouck Jacobs** on The Involuntary Civil Commitment Process. The Involuntary Civil Commitment Process is a function of the Probate Division of the Circuit Court. Learn the basics of how a

person ends up in the involuntary civil commitment process, how the process works once it has started, and how you can get on the list of attorneys appointed (and compensated) to represent individuals in these situations. At the end of this program, you will have a functional understanding of the involuntary civil commitment process and the nitty-gritty as to how you can represent individuals involved in this process and what that representation entails. The program has been approved for 1.2 hours of CLE credit.

Lunch will begin at 11:30 a.m. on February 9 at the Columbia Country Club, 2210 N. Country Club Dr., Columbia, MO. The CLE will begin around noon.

13th Circuit Streamlines Trial Setting Docket

Trial dates will now be set faster under streamlined processes regarding the 13th Judicial Circuit's Trial Setting Docket. These internal changes will allow for cases to have trial dates assigned within days of making the request, compared to waiting weeks as it was sometimes previously taking. With this change, it is critical that attorneys keep their 13th Circuit Attorney Conflict Calendar updated so



that trial dates can be set most efficiently. It is also recommended that parties submit a list of exclusionary dates along with their request for trial. This change will affect all trial settings, including criminal, civil, and family court matters. This is part of the 13th Circuit's renewed commitment to prompt and fair disposition of cases.

Boone County Bar Scholarships Awarded

Each year, the Boone County Bar Association Scholarship Committee selects a recipient for the Bar's annual \$2,500 scholarship from one of the high schools in Boone County.
