In addition to the BCBA Attorney Composite, a portrait of the late U.S. District Court Judge Scott Wright will also be unveiled.


After the unveilings at the Boone County

# The BCBA mourns the passing of Prosecuting Attorney Dan Knight and criminal defense attorney Stephen Wyse

June was a sad month for the Boone County Bar Association with the passing of two stalwart members of the local bar.



On June 4, 2022, **Dan Knight**, son of long-time BCBA member, **David Knight** and Sandra Knight passed away at the age of 55.

Dan spent his entire legal career in the Boone County Prosecuting Attorney's Office, beginning in 1992 as an assistant prosecutor until he became the Prosecuting Attorney in 2007, the position he held for the rest of his life.

Dan's life-long friend and fraternity brother, **Ed Orr** made heartfelt and touching remarks regarding Dan at the June BCBA meeting, sharing a number of memorable stories of the times they spent together and Dan's contributions to the local community.

Private services were conducted by the family and a celebration of Dan's life is planned for the fall. Memorials in Dan's honor are suggested to Central Missouri Humane Society, Columbia Second Chance, or the donor's choice. Online condolences may be made at www.memorialfuneralhomeandcemetery.com.

Two days later, criminal defense attorney Stephen Wyse passed away on June 6, 2022.

Steve founded the Wyse Law Firm in 2002. During his practice, Steve handled criminal defense, DWI/DUI defense, personal injury and civil rights matters, including a number of high-profile local cases. At the time of his passing, Steve was preparing for a seconddegree murder trial set to begin in August.

Prior to his legal practice, Steve served in the U.S. Army from 1984 until 1998 as a military policeman. After the



military, Steve obtained both an undergraduate degree in history and his law degree from the University of Missouri.

Steve's full obituary is available online. A public memorial service is planned for July 10 at 3:00 pm at McNally's Irish Pub in downtown Columbia. All are invited to raise a glass and tell a story. Details for the memorial service are available on Facebook.

## Professor David Mitchell presented at June BCBA Meeting



During the June, 2022 meeting, MU Law School Professor, S. David Mitchell presented a timely and engaging discussion of the intersection of politics, race, and First Amendment Rights. Professor Mitchell covered the history of Critical Race Theory, how that term has come to be used in popular parlance, recent legislative actions regarding school curricula, and a survey of the key cases discussing freedom of speech and religion in the public education setting.

Following his prepared remarks, Professor Mitchell spent several minutes answer questions and responding to comments from the members in attendance.
