
BCBA Scholarship Applications Due by June 15



Mid-Missouri Legal Services Announces Judicare Attorney Rate Update

Mid-Missouri Legal Services (MMLS) delivers legal services to eleven counties in central Missouri. Private attorneys – through MMLS' Pro Bono and Judicare (reduced fee) programs – are critical to the organization's mission to increase access to justice for low-income families in these communities. **In recognition of the important role private attorneys serve for these communities, MMLS has updated the rate paid to Judicare attorneys to \$100 an hour**, with a maximum amount based on the type of case.



MMLS refers the following cases to Judicare attorneys: divorces, paternity/custody, uncontested guardianships, landlord-tenant, bankruptcy, small business counseling and transactional documents, and wills, financial powers of attorney and beneficiary deeds for the elder, the disabled, or those with a terminal diagnosis.

If you are licensed to practice law in Missouri, please consider volunteering as a MMLS Pro Bono or Judicare attorney. You benefit from valuable experience, access to forms, and advice from experienced staff attorneys. In addition, MMLS saves you time by screening clients, collecting basic case information, conducting merit assessments, and making the referrals. You may accept or reject referrals based on your comfort with both the time commitment and subject matter of the case.
