### Chris Dunn, Ben Faber, Dale Roberts Receive Pro Bono Awards



## Missouri Court of Appeals, Western District, to sit at University of Missouri School of Law and Westminster College in Fulton

The Missouri Court of Appeals, Western District, is scheduled to convene court Wednesday, November 8, 2023, at the University of Missouri School of Law. The arguments will be held at Hulston Hall on campus. Beginning at 1:30 p.m., a three-judge panel consisting of Chief Judge Gary Witt, Judge Alok Ahuja and Judge Mark Pfeiffer will hear oral arguments in four cases on the docket. After the oral arguments, the judges will take time to discuss the court system, explain the proceedings and take general questions from the audience. Witt will preside over the proceedings. Witt was appointed to the Western District in 2010. Prior to his appointment, he served as an associate circuit judge in Platte County. Ahuja joined the Western District in 2007. Previously, he practiced law in Washington, D.C., and Kansas City. Pfeiffer was appointed to the Western District in 2009. Before his appointment to the judiciary, he practiced law in Springfield and Columbia. The court regularly convenes court in Kansas City. For more than 25 years, however, the court has held dockets in several of the 45 counties in the court's jurisdiction, which includes all of northwest Missouri and most of central Missouri. The court convenes oral arguments outside of Kansas City to give individuals an opportunity to observe a part of the judicial system they normally do not see and to familiarize those attending with the court's role in the judicial system.

And the court will convene on Thursday, November 9 at 9:00 a.m. at Westminster College in Fulton. The arguments will be held in the Hermann Lounge at the Hunter Activity Center on campus. The three-judge panel will consist of **Judge Mark Pfeiffer**, Judge Alok Ahuja, and Judge Thomas Chapman and will hear four cases. Pfeiffer will preside over the proceedings at Westminster. Chapman was appointed to the court in 2018. Immediately prior to his appointment, he served as a circuit judge for the 43rd Judicial Circuit for more than seven years and he is a 1988 graduate of Westminster College.

## Christine Stamper Competed in World Championship Triathlon

Christine Stamper was one of 2,100 female athletes from 73 countries to compete in the women's 2023 VinFast IRONMAN World Championship triathlon on October 14, 2023 in Hawaii.

For the first time in the event's 40-plus year history, the spotlight shone exclusively on female triathletes. The race began in the crystal-clear waters of Kailua Bay for 2.4 miles before heading out on the 112-mile bike course, renowned for its long-sustained climbs, strong crosswinds, and exposed terrain with lava fields on one side and the ocean coastline on the other. The final leg of the race was a 26.2-mile run, an out-and-back that took athletes onto the Queen Ka'ahumanu Highway before returning to the finish line on Ali'I Drive.

Athletes must complete the course within 17 hours and the stroke of midnight. Christine's finishing time was 15:05:00."

Pursuant to Rule 5.30(c), the Legal Ethics Counsel, on behalf of the Advisory Committee, may provide informal advisory opinions interpreting Missouri Supreme Court Rules 4, 5, and 6 in response to telephone and written ethics questions from lawyers. The primary role of the staff counsel is to answer these ethics questions, and the ideal candidate must have excellent communication, writing, and research skills, as well as sound judgment, to ensure that each ethics inquiry is handled consistently and professionally. A keen interest in listening, asking questions as appropriate, researching, and problem solving is required for this position. ### Presiding Judge Brouck Jacobs Delivered State of the Court Address Last Month

At the October 11 meeting of the BCBA, **Presiding Judge Brouck Jacobs** delivered the State of the Court Address for the 13th Circuit Court. An item of note was that in 2022 the Missouri Supreme Court awarded the 13th Circuit with the Daniel J. O'Toole Award. Named for the late judge who first chaired the state's Time Standards Monitoring Committee, the O'Toole Award recognizes a circuit court's excellence in service and delivering timely justice to



the public. The 13th Circuit had an average clearance rate of approximately 101.6 percent, meaning it closed more cases in fiscal 2022 than were filed during the same time frame. This was the first time the 13th circuit received the O'Toole Award.
